## NEWS IN BRIEF

### Reports of animals injured or caught in litter

The RSPCA is urging people who are going out more since lockdown restrictions were eased to ensure they are taking their litter home with them, or disposing of it properly and responsibly.

Over the past five years, the RSPCA's emergency hotline in England and Wales has received 6,466 calls about animals affected by general litter – like tin cans, plastic bottles and elastic bands. There have also been 15,183 reports relating to animals injured or caught in angling litter. There have been a further 12,904 reports of animals and birds trapped in netting, which includes netting discarded as rubbish but this also includes sports netting or netting put on bushes or trees to deter birds.

The charity's frontline officers are regularly called to help cats, birds and wildlife who have got themselves tangled in netting, injured in fishing litter or stuck in rubbish, whether it's a fox with a tin can stuck on its head or a seal with fishing netting wrapped around its neck cutting into the flesh.

## £40K COUNCIL FUNDING ON OFFER FOR LOCAL PROJECTS

East Northamptonshire Council (ENC) is once again pledging to help more communities across the district with £40,000 of funding for local projects.

Every year, each ENC district councillor is allocated £1,000 each to spend on small community-based projects. The money can be awarded to parish/town councils, community groups, voluntary organisations and charities who work in East Northamptonshire.

The funding stream, known as the Member Empowerment Fund (MEF), supports community events, sports

activities, environmental enhancements, local facility improvements, equipment for youth groups and projects that promote safer communities.

Since MEF started in June 2011, communities have benefitted from over £288,000 of grant funding and recent examples include:

- The creation of two wildlife grass verges in the village of Titchmarsh
- Purchase of a community

defibrillator for the residents and visitors of Top Lodge in Fineshade

- The purchase and installation of a finger post sign to waymark a new path in Higham Ferrers
- Refurbishment of the town sign at the entrance of Irthlingborough along the A6
- The installation of a defibrillator in Lowick and Slipton

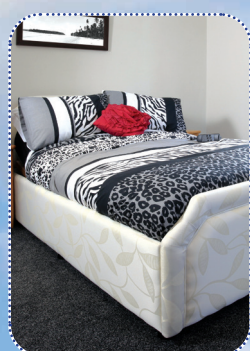

# GENEALOGY JOTTINGS



*I realised the other day that I have been 'genealogy jotting' in the Nene Valley News for just over five years. Doesn't time fly! Even technology has changed a great deal during that time with more and more websites scanning documents, thus making them available for folk to see from the comfort of home.*

In delving back into my family history during social distancing, I have found a number of gaps, which I have been trying to fill. Handily, some of those gaps are being filled by information that was not available 20 or more years ago. I have found some scanned marriage certificates online, which have saved me from ordering copies from the General Register Office. This is particularly useful when the couple involved are more distant than a direct line and so would not usually warrant

**the cost of ordering the certificate.**

However, not everything is available online and I will be glad when I can visit archives once more. There is nothing like seeing the original documents! One original document that I have in my possession is that of an indenture dated 1st February 1825. It covered the sale of a 'messuage' – a house with outbuildings and land – in Tenterden, Kent. It is written in a cursive script that, whilst beautiful to look at, is not the

easiest to read. The document itself measures approximately 75cm by 60cm and is covered in this writing. Every so often, I get it out and transcribe some of it, wondering at the flowery language used. Drawn up by a solicitor – or their clerk – of the time, they certainly didn't use one word when 20 would do.

Actually, drafters of legal documents back in the day (called scribes) were once paid by the word, as opposed to assignment or document, which explains a lot!

# SEARCH IS ON FOR **NEW SENIOR OFFICERS** FOR UNITARY COUNCILS

*A national recruitment drive has been launched to find and appoint the chief executives and statutory director roles that will head up Northamptonshire's two new unitary councils.*

Legislation requires that by the end of December this year, a permanent Chief Executive, Monitoring Officer and Chief Finance Officer (Section 151) must be in place for each of the North

and West Northamptonshire unitary councils, which will be created on 1st April 2021.

Recruitment is also underway for a Director of Children's Services covering

both North and West unitary councils to manage the countywide contract for the planned Northamptonshire Children's Trust; as well as two Directors for Adult Social Services, one for each new authority.

"We want to make appointments as early as we can to enable whoever we appoint to be directly involved in the many key decisions we will have to make."

Councillor Ian McCord, Leader of the West Northamptonshire Shadow Authority added: "We have a chance for a new beginning, we have one opportunity to get this right.

"To be successful we need to recruit the very best talent to lead and shape the creation of the new council alongside us politicians.

"This is the beginning of a process to ensure that we can have a fresh start and a bright future."

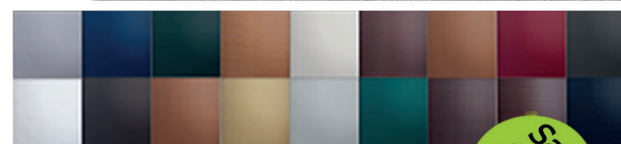

# CELEBRATE SUMMER AT HOME WITH **BRITISH STRAWBERRIES**

British strawberry growers are excited to announce that the much-anticipated British strawberry season is now here! Warmer and sunnier spring weather has meant that the season has started around a week earlier this year and strawberry lovers can now buy their favourite British fruit in supermarkets (in-store and online) around the country.

Many social events might be off the calendar this summer, but British strawberries can be enjoyed at home or in the garden as part of classic summer moments. From garden picnics or BBQs, to Wimbledon-inspired strawberries and cream from the comfort of your couch, British strawberries are here to remind everyone that despite recent challenges summer has arrived.

## > GIANT STRAWBERRY CHOC CHIP COOKIE

This is a fun sharing treat or pudding served warm with ice cream. Grab a spoon and dig in!  
Serves 4-6

Prep time: 10 minutes  
Cook time: 30 minutes  
(V) Make it vegan with plant based milk, vegan chocolate and ice cream.

### Ingredients

100g oats  
50g ground almonds  
1/2 tsp baking powder  
50g coconut sugar or brown sugar  
60g coconut oil, melted  
1 egg, beaten  
2 tbsp milk  
1/2 tsp vanilla extract (optional)  
50g dark, milk or white chocolate, roughly chopped  
125g strawberries, hulled and chopped  
Ice cream to serve

### Method

- Preheat the oven to 180C/fan 160C/gas mark 4. Base line a 20cm round tin or ovenproof dish. Place the oats in a food processor and blitz to a small crumb. Add the ground almonds, baking powder and sugar and blend just to combine.

- Melt the coconut oil in a pan. Remove from the heat and stir in the oat mixture with all remaining ingredients, except the strawberries. Spread the mixture in the tin or dish, scatter over the strawberries and bake for 25-30 minutes until golden and just set. Cool slightly before serving with scoops of ice cream on top for everyone to share.

### Tip

Make two of these and freeze one before baking to cook later straight from the freezer – just add an extra 5 minutes cooking time. If you don't have a food processor to blitz the oats, substitute half the oats with any type of flour. Any type of dairy or plant based milk can be used. You can also use melted vegetable margarine or butter in place of the coconut oil.

## > INSTANT STRAWBERRY FREEZIE

Keeping a store of berries in the freezer means you can make this an instant treat. Try it with any berries, adjusting the amount of honey or syrup according to how sweet you like it.



Giant strawberry choc chip cookie

Instant strawberry freezie

Makes 4 scoops  
Prep time: 5 minutes plus freezing time  
(V) Make it vegan with plant based yogurt and maple syrup

### Ingredients

200g strawberries, hulled and chopped  
1 ripe banana  
1/2 tsp lemon juice  
2 tbsp low fat yogurt  
1/2 – 1 tbsp honey or maple syrup (optional)

### Method

- Freeze the strawberries overnight

then simply add all the ingredients to a blender or use a stick blender to blitz into ice cream. Serve immediately in scoops, in a cone or freeze for later.

### Tip

If you don't have a blender simply mash the fresh unfrozen strawberries with the banana and other ingredients and still freeze until firm enough to scoop.

A great way to use a glut of fruit – just size up the recipe accordingly. Ripe fruit is often sweet already so taste before adding all the honey or maple syrup. This works well with raspberries too.

## Renewed demand for rural property

I am sure that we are all relieved that some of the elements of the coronavirus lockdown are starting to be eased. It is also positive that the Government has recently issued updated guidance which allows the resumption of residential estate agency activities.

Developers are already adapting to the changes with a number looking at the internal layouts of the properties to accommodate areas suitable for home working and home leisure.

Our local area has huge potential to fulfil this demand with some very attractive villages and market towns that provide a good range of local

services. The recent installation of fibre optic cables across this area has increased the availability of superfast broadband in many properties. We are also in an area with abundant scenic countryside offering outdoor leisure pursuits including walking, cycling and water based sports. Another key driver for demand is the good connectivity to infrastructure and regional commercial centres which has been further enhanced with the opening of the new A14 alignment to Cambridge.

We are going through a period of considerable change and we are likely to see this impacting upon where people live, work, shop and take their leisure activities. Our area has the potential to benefit from some of the structural changes that we are beginning to see and we look forward to working with our community in the 'new normal'.

# Go wild in June! Spend 30 days wild

Since it started back in 2015, more than a million people countrywide have taken part in the Wildlife Trust's 30 Days Wild, and this June, as the UK battles social restrictions, people are looking for ways to keep spirits up and entertain young families. While time spent outside may be limited, daily nature activities – even at home – can open a door to a world of sensory delights, from listening to birdsong to growing a pot of wildflowers on a windowsill.

A new review has shown that a long-lasting feel-good factor comes from taking part in the annual initiative. The University of Derby has evaluated survey responses from more than 1,000 people over five years and discovered the enduring effects

on wellbeing from participation – the positive effects are still felt two months after the challenge is over.

People rated their health, nature connectedness, happiness and pro-nature behaviour before beginning the challenge, again at the beginning of July when the challenge had finished, and then for a third time in September, two months after the challenge had finished. All positive increases were maintained both immediately after the challenge and also two months later.

Ellie Harrison, TV presenter and Vice President of The Wildlife Trusts, says: "We are all, but for 200 years of industrialisation, creatures of the land. It's why nature looks beautiful to us; why we know

how to be in nature; and why nature makes us feel content. 30 Days Wild reminds us to notice nature in small moments every day. The stillness of even a few seconds changes our relationship with the planet and connects us with the truth of who we are."

Professor Miles Richardson, Professor of Human Factors and Nature Connectedness at the University of Derby, says: "This five-year evaluation of 30 Days Wild has produced remarkable results – it shows the positive power of simple engagement with nature. We were thrilled to see significant increases in people's health and happiness were still felt even two months after the challenge was over."

## > WILD INSPIRATION

Get inspired by Sharon Williamson who immerses herself in nature each year during the 30 Days Wild annual initiative. Working in ink and watercolour she creates stunningly detailed images of her encounters with nature – the birds, insects and plants which she finds in her garden or visits outdoors.

Sharon has always been a 'nature nut' who loves drawing and first took part three years ago, using it as a great excuse to explore some of the nearby nature reserves that she hadn't visited before, recording wildlife

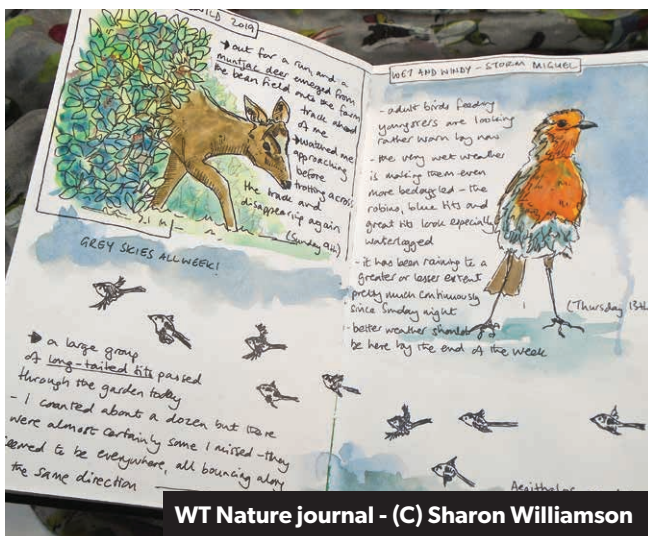
which "kickstarted" her nature journaling.

Sharon records nature throughout the year and has held workshops with the Cambridgeshire Wildlife Trust, helping others enjoy and develop their own approach, having just run her first nature journaling session at Paxton Pits education centre when the Covid-19 restrictions began.

This year she's going to try using wine ropes to attract moths – strips of fabric soaked in sugar and red wine hung outside to attract night time flying feeders, and inspect by torchlight to see which moths enjoy the feast. She is also interested in journaling the sounds she hears to create a series of mini soundscapes: "If we slow our mind and tune in, it's amazing what we can hear. I'll be aiming to create a soundscape a week by listening and noting the various sounds I can hear from the garden, at different times of the day."

## Wildlife NEWS

With the weather there are always "winners" and "losers". Some species do well while others find progress hard (even without the chaos caused by the coronavirus disaster). Signs of stress are often easy to see: plants wilting or dying, water levels in streams or lakes dropping (even red skin on those who sunbathed a little too long!), all show how quickly we forget the sun until it is too late.

In the countryside all creatures can have problems. Plants cannot uproot themselves and look for better spots, and temperatures essential for plant growth can be cancelled out by the lack of water so the plant's chemistry cannot produce the crops we want, and agricultural enterprises find serious difficulty. It is not always simple to decide whether the weather is good or bad for wildlife, though some signs beyond what we report in this column can give some hints. One of the most obvious is the abundance of insects which seem to delight in plaguing us.

In years like this, with record sunshine totals, it often feels hard to take a breath without gathering a mouthful of flies or midges. Some parts of the world have to cope with plagues of insects like locusts, but our rural areas generally provide the right kind of conditions so we have some measure of control over these mass invasions – though the weather can always surprise us.

With lots of insects around us, from thousands of different species, one pleasing feature is that all nature-lovers have more chance to learn of the unusual ones; but we must often forget our natural reaction to swat any unknown creature which upsets us by daring to fly in our airspace. We should look for those with unusual markings/colouring; for example, an insect which apparently cannot decide what to call itself – one of the bee-fly family. It will not bite or sting, but teaches a little more about identifying insects, because it feeds through a tube which is placed where we might expect to find its nose, giving it a look of having a straw sticking out of its head. Never seen one? – just keep looking (and let us know!).
