Birth registration service re-opens via **online booking system**

Following Government guidance clarifying that registration services are now permitted to open in England, Northamptonshire County Council's registration service has re-opened to take birth registrations, notices of marriage and corrections via an online booking system.

Initially, face-to-face appointments will take place by invitation only and customers with outstanding exceptional birth registrations or those who had their birth registration appointment cancelled when lockdown was first implemented will be contacted first. Customers will be asked to complete and return a birth

registration questionnaire in advance to minimise their time in the office, and will then be contacted to arrange an appointment. The number of people attending the office will be kept to the legal minimum required to complete a legal registration and all payments for certificates will be taken in advance.

Following Public Health guidance, screens have been installed in each office and wipes, hand gel and pens have been distributed across the service. The council is still awaiting Government confirmation as to when ceremonies can be recommenced.

Have you ever thought about publishing your family's history? If your family is like mine, it would run to several volumes and knock 'War and Peace' into a cocked hat! When you find that you are related to (almost) everyone in a particular village it can end up like trying to knit fog!

It might be that you just want an account of the facts of who your family were – their births, marriages and deaths etc – but every so often you hit upon a person whose story really grabs you.

I am thinking about possibly recounting the stories of some of the characters in my own

family: my great grandfather who ended up in Saffron Walden gaol for two weeks for 'threatening Farmer Hagger with a hayfork'; my several times great grandfather who, as a blacksmith, was responsible for the ironworks on Henry VII's ships; or maybe my great uncle who, after being told he was unfit for the Army in WW1 (he had epilepsy) was discharged, changed his name and moved over 250 miles away from the rest of his family.

Perhaps a book of individual characters to be found amongst your ancestors might prove to be a way of garnering curiosity. But how do you go

about it?

Professional publishers can be very expensive and could result in you having to have a minimum number of books printed, but other options are available. Have a rummage online – there are some where your 'book' would be kept in the ether and only printed when a copy is needed. Self-publishing is another option. A cousin of mine in Australia did this and I now have a copy of his book about one of our common ancestors, Frank Moon, who was born in Kent in 1836 and emigrated to the other side of the world. Worth thinking about?

Concessionary bus pass arrangements in Northamptonshire return to normal

Concessionary bus pass arrangements in Northamptonshire have returned to normal as of 15th June. The passes allow eligible older and disabled people to travel for free from 9.30am to 11pm on weekdays, and all day at weekends and bank holidays.

In March, Northamptonshire County Council agreed to

temporarily extend the current bus concessionary travel scheme to 24 hours a day, to enable older and vulnerable residents to access essential services, such as early morning food shopping.

But with lockdown restrictions easing and social distancing measures remaining in place, the capacity of services may be

reduced, therefore limited peak-hour travel is prioritised for those who may work in shops or factories, or for education.

County Council Cabinet Member for Place, Highways and the Environment, Cllr Jason Smithers said: "Supermarkets are more accessible now than at the beginning of the crisis and the

easing of lockdown restrictions means more people will be using public transport for work and school.

"Social distancing measures are in place on buses and as some services

may be reduced, we want to ensure there is enough room on routes for workers and pupils, while ensuring concessionary pass holders can still enjoy free travel."

CHANGES TO TOWN CENTRE PARKING

Parking enforcement in Northampton has been reintroduced to support shops and businesses as they re-open following the Covid-19 lockdown.

Northamptonshire County Council will be enforcing on street pay and display parking. This means motorists must purchase a pay and display ticket before leaving their vehicle parked and all maximum stay and no return time limits associated with pay and display bays will apply.

Northampton Borough Council will also be reintroducing parking charges in its car parks from 29th June.

Free parking will continue to be given to the

NHS, health and social care workers and NHS Covid-19 volunteers in line with the government's free parking concessions. A Government Parking Pass or a pre-agreed parking permit must be clearly on display in the vehicle.

Northamptonshire County Council Cabinet Member for Environment and Place, Councillor Jason Smithers said: "We temporarily suspended on street pay and display charging at the start of the pandemic, but as the county begins to reopen we need to ensure that effective parking enforcement is in place to support this, allowing shoppers to park near their destination and bring people back into town centres.

"Free parking will continue to be given to the NHS, health and social care workers and NHS Covid-19 volunteers in line with the government's free parking concessions. The current residents' permit parking arrangements will also continue until the end of the month when they are due for review.

"All motorists are reminded that they should not park dangerously or cause an obstruction including blocking a dropped kerb, on zigzags at crossings, in loading restrictions and on yellow lines protecting junctions. It is vital that we keep the county moving, maintain traffic flow and focus on safety and access for emergency and essential services."

All pay and display machines will, where possible, have social distancing markings in place around the machines. While a regular cleaning regime will be in place, customers are advised to cover their fingers to press buttons. It is also recommended that customers wash/sanitise their hands as soon as possible after using the machine.

UPDATED GUIDANCE ON **tradespeople** working in the home

As the lockdown slowly begins to ease and more people consider having work carried out in their homes, new guidelines have been issued to help keep households in Northamptonshire safe.

The updated advice from the Government outlines the precautions homeowners may see professional tradespeople take when visiting their homes to provide heating, plumbing or maintenance services.

The guidance has been welcomed by OFTEC, the registration body for off-grid heating work, which has put together a checklist for consumers so they know the precautions workers may take and the standards they should expect from professionals.

Households must continue to follow two-metre social distancing rules and work must not be carried out if either the tradesperson or any occupants display Covid-19 symptoms, or where an individual has been advised to shield – unless it is to remedy a direct risk to the safety of the household.

The additional measures tradespeople may take include:

- Communicating with households

prior to arrival to ensure social distancing and hygiene measures are clearly understood and followed before work commences

- Wearing additional Personal Protective Equipment (PPE) and regularly washing their hands
- Holding any conversations outdoors or in a well-ventilated room
- Arranging methods of safely disposing of any waste with the householder
- Not sharing pens, paper or other items and declining refreshments
- Households in Northamptonshire can also help to keep both themselves and tradespeople safe by:
 - Keeping surfaces and rooms where tradespeople are working clean and ventilated
 - Not entering the room while work is being carried out unless absolutely necessary

- Clearly outlining the work required, providing photos if possible for the tradesperson before arrival to reduce the amount of time they need to spend in the home
- Carefully reviewing any new measures shared by the tradesperson before they arrive and clarifying any questions or concerns with them in advance
- Paying by bank transfer and not using cash

Malcolm Farrow of OFTEC, commented: "As the government slowly starts to ease some of the lockdown measures, more tradespeople will be working in peoples' homes across Northamptonshire. As long as the new guidelines are carefully observed, consumers should feel safe having heating technicians, plumbers and other professionals in their home.

"We can all help make things easier by accommodating the new rules tradespeople are following and raise any issues or concerns before the work begins. Households must remember to continue to follow the two-metre social distancing rules and it's vital that no work is undertaken if either the tradesperson or someone living in the house is showing any

Covid-19 symptoms.

"For the households in Northamptonshire who need to have work completed on their heating system, always ensure you use a GasSafe, for mains gas, or OFTEC, for oil heating and solid fuel, registered technician as they are fully qualified and all follow strict safety guidelines."

Businesses advised to assess **Legionnaires'** disease risk

Businesses which have had to close buildings or reduce occupancy or activity during the Covid-19 outbreak are being advised to carry out risk assessments prior to reopening, as water system stagnation can occur due to lack of use and increase the risks of Legionnaires' disease.

Employers, the self-employed and people in control of premises, such as landlords, have a duty to protect people by identifying and controlling risks associated with Legionella. This means businesses are responsible for carrying out a risk assessment, to determine whether further action is required to ensure premises are safe to reopen.

Legionnaires' disease is a lung infection, caused by inhaling small droplets of water, suspended in the air, which contain Legionella bacteria. Legionnaires' disease is rarely

transferred between people and can be treated with antibiotics, however of concern at the moment is the fact that symptoms are similar to those linked with Covid-19, so people may not recognise they have been infected.

Symptoms of Legionnaires' disease include a high temperature or fever, a cough, along with muscle pains, a headache and sometimes pneumonia. People who are feeling unwell with similar unexplained symptoms should ring NHS 111.

Lucy Wightman, Director of Public Health for Northamptonshire said: "This has been a very challenging

time for businesses, with many sites needing to close or limit occupancy for a considerable period of time. Businesses should seek to be proactive in assessing the risk of Legionnaires' Disease occurring within their workplaces to minimise the risk caused by this potentially fatal illness as they prepare to reopen.

"Each of the borough and district councils have Environmental Health Officers who are working hard to support businesses and workplaces in returning to work, so please use this resource to support you in taking the necessary steps to ensure that your workplaces are safe."

Residents asked for views on **Cotterstock village planning document**

East Northamptonshire Council is consulting the public on an essential planning document which provides more detailed guidance on the design of future new development in Cotterstock village.

The Cotterstock Village Design Statement Supplementary Planning Document (SPD) was approved for Public Consultation by East Northamptonshire's Planning Policy Committee on 8th June 2020.

After carrying out a Village Design Survey (VDS), the VDS was drafted by a working group comprising members of the Cotterstock Parish Meeting and was presented to East Northamptonshire Council in September 2019. The Survey, which forms Appendix 1 of the document, led to a range of guidelines being developed, to cover:

- Landscape
- Buildings and design
- Highways and street furniture
- Amenities

Informed by the Village Design Survey, the VDS aims to:

- Set out a distinctive local vision for Cotterstock village for the period up to 2031
- Ensure that future development within the parish acknowledges the existing

landscape character and settlement pattern and that planning applications have taken these into account

- Protect the unique character and appearance of the Conservation Area
- Protect important views, landscape character, open spaces, mature trees, natural landscaping features, wildlife and natural environments.

The current draft of this document Cotterstock Village Design Statement – Supplementary Planning Document will be subject to a period of Public Consultation between Friday 26th June and Monday 10th August, 2020. Residents can have their say on the document online at https://www.east-northamptonshire.gov.uk/downloads/file/11861/draft_cotterstock_village_design_statement

Once the Public Consultation has been assessed, the Council will update the document. This version will be presented to the next available Planning Policy Committee for their approval, with a view to adopting the document as a Supplementary Planning Document, to form part of the Local Development Plan Document for use in the determination of Planning Applications and in giving general planning advice.



East Northants Council drives economic recovery across district

As part of its continued support to local businesses, East Northamptonshire Council (ENC) has been working closely with partner organisations and stakeholders to ensure they are supported during the coronavirus pandemic.

Teams from across the Council have been working hard to ensure that all businesses that are entitled to support receive it and since the start of the pandemic, ENC has paid out over 1,300 grants totalling nearly £15m and business rate relief of around £13.1m and are also currently working through applications to a new scheme for businesses that may have missed out in the initial rounds of grant funding.

As well as financial support, ENC's economic development service, Enterprising East Northants (EEN), has strengthened existing relationships with partners from across the county, including the University of Northampton, the SEMLEP Growth Hub, Federation of Small Businesses and Wellingborough and East Northants

Chamber of Commerce, to launch the Recovery Through Enterprise campaign.

Launched to support those most in need, the campaign offers personal 1:1 business advice, as well as access to a wide range of support webinars and resources. It will also include working with the EEN skills group to provide employment support for residents who have lost their jobs as a result of the pandemic. The team behind the campaign will be based at ENC's new Enterprise Centre East Northants.

Steven North, Leader of East Northamptonshire Council explains more: "As a Council, we have a responsibility to help those businesses in need across the district and everyone at ENC is working hard to ensure

that businesses get the advice and financial support they need especially at this difficult time.

"We are proud of the work we have done so far to help so many businesses, but always want to do more and we are continuously looking for new and innovative ways to assist, like the Recovery Through Enterprise scheme, which includes helping locals towns to re-open their high streets and commercial areas safely."

ENC has also been given a grant of £84,908 which will support the work to drive economic recovery across the district. This work is being supported at a countywide level through the Safer Public Places initiative which will see a range activity aimed at improving public safety with a particular emphasis on encouraging walking and cycling.

Town council mourns death of past Mayor

It was with great sadness that the Higham Ferrers Town Council and staff received the news of the death of former Mayor Paul Gadsby on 11th June following a short illness. He had served as a Borough Councillor from 1969 and then as a Town Councillor until May 2011. He was Mayor in 1998-1999.

Paul was one of the most polite, caring and understanding people you would wish to find. Indeed I feel very privileged to have known him.

"Having served

with Paul on the Town Council for several years he was always keen to help new Councillors in any way he could, and indeed was a great help to me when I first became a Councillor. Being such a quiet and unassuming man it did take him a few years before he decided that he would like to become the Town Mayor, and this

was a position he carried out in the excellent manner you would expect from him.

"It was with great sadness that we heard the news that Paul had passed away following a short illness, and he will be sorely missed not only by fellow Councillors, but also members of the local Methodist Church."

This time of year would usually be busy with lots of different events on campus, showcasing the range of courses and facilities on offer. While the events calendar looks very different this year, it hasn't


Wildlife NEWS

Our wildlife has hopefully solved its housing problems for the new young families, but the parents' job actually gets harder (old proverb: 'no peace for the wicked') as most will now have to meet the demands of raising the new generation. Soon they will start to look rather worn-out, with tatty feathers and nest entrances scuffed and more exposed; some may even die of exhaustion.

Some interesting and revealing sights at this time of the year happen during the night hours, when perhaps the day's work has left the parents a little 'tetchy', or even asleep, but other life does not stop. The garden CCTV (not one of the top-flight models, unfortunately!) does start to reveal more of the after-dark happenings, as with a couple of very unexpected glimpses recently.

Earlier, when males were looking urgently for suitable mates to make a strong family unit, chasing a partner was a most important job on the list, especially if suitable females were in short supply. Hedgehogs are not



everyone's model of a speedy athlete, but given a chance the camera showed that both of them were running quite hard before they disappeared into the night.

The second surprise again concerned hedgehogs, basically creatures of the night; occasionally better lighting conditions produce an overlap between daytime and night-time activities; the camera triggers when the subject moves, and that gap can show as day becomes night and vice versa. On one occasion the hedgehog, having arrived at the dish of food, was munching its way in when a carrion crow arrived;

all fairly commonplace, until the crow decided that it was frightened of the hog's spines but the thought of food was strong enough to keep it trying, and it started a comical dance routine – while the hedgehog simply carried on eating! At last the hog had eaten enough and wandered off into the nearby plants; unfortunately (for the bird) there was not enough food left for the crow to spend time for the crumbs, even as the light strengthened, and it flew off for a better breakfast. The night's programme had come to an end, though the nightlife would continue somewhere else.
