## NEWS IN BRIEF

### COVID GRANT FUNDING TO SUPPORT VULNERABLE HOUSEHOLDS

Help for people needing extra support this winter will be available following the announcement that Northamptonshire County Council has received funding from the government's Covid Winter Grant Scheme.

The county council has been given £2,080,000 from the grant which aims to provide support for those households who are most in need.

In Northamptonshire £750,000 from the grant will be used to provide shopping vouchers for families with children who are eligible for Free School Meals during both the Christmas and February half term school holidays. The rest of the grant funding has been allocated to the Household Winter Support Scheme. This scheme builds on existing community resilience work to use a network of established partner organisations to distribute a one-time voucher of support to help those most in need. The county council has also been allocated £464,280 to support the Clinically Extremely Vulnerable.

# Higham still sparkles in 2020

Sparkle in Higham Ferrers has become an increasingly popular Christmas event over the years. The community come together for a day of festive fun with a continental market, fair, and an array of entertainment on the stage before culminating in the Christmas lights switch-on by the Mayor.

Unfortunately the traditional Sparkle day was cancelled this year due to Covid. On Saturday 21st November the Town Council hosted a virtual lights switch-on on Facebook and YouTube. The Mayor, Councillor Tina Reavey, was



joined on social media by local school children and a few other familiar faces in the town for a special countdown before the familiar warm white lights came on, bringing sparkle and magic to the Market Square and High Street.

Those who have passed through the Market Square recently will have seen that in addition to the lights there are a few extra Christmas treats for residents.

A Christmas tree stands proudly, adorned at the top with a star and covering of twinkling lights. Many towns have a Christmas tree but this year Higham Town Council also wanted to bring a little something extra, something unique, something to help lift spirits when so many face ongoing restrictions due to Covid – something that the community could become involved with. Thanks to some very creative locals they have been able to decorate the Market Square with wonderful knitted and crocheted decorations; yarn bombing has arrived with real Christmas spirit.






# WILDLIFE NEWS

The end of the calendar year, as we all know, is far from the end of winter. We now watch for warnings of what winter shocks may be on the way.

The Christmas shopping and cooking are over, as well as the festivities, often with their excesses of food and drink, which may provide a little more fuel for our bodies to see us through the lower temperatures to come.

Many, especially insects, will have found a 'cosy corner' where they can see the winter through as if they were dead (many will look like that if we happen to come across them, so do not touch!). Plants, however, face different difficulties.

During the summer plants of all kinds from tiny 'weeds' to towering tree giants spent time and energy preparing for the next generation by producing their seeds. Now the problem is how to distribute the results.

They have no sophisticated systems and must recruit helpers by offering attractions like seeds, berries and currants. And just as our courier

drivers have been working hard to deliver our parcels so the animal life in these winter months is not only responsible for holding hope for next year, but also the fillings in those fruits are providing tasty meals for the hungry birds and mammals finding their way around and needing nutrition because they have chosen not to sleep (hibernate).

In a way it looks as if nature is fighting against itself, with half the inhabitants trying to catch and eat what the others are producing for their own ends – though they never seem to run into population problems until we step in and interfere.

It's all a question of numbers, as we have been told so many times recently with the virus. We do not need thousands of oaks or any other trees every year, as long as there are enough each time.

Our cooking experts can have their special ingredients for unexpected treats – and we should remember that for others the 'specials' may be life-saving rather than just tasteful tidbits.

# GENEALOGY JOTTINGS

When you are looking into your tree, how far sideways do you go? Although I have known about the parents of three of my grandparents since the year dot, it was not until I started buying the birth, marriage and death certificates that things got serious.

One of my great grandfathers was John Smith. Not the easiest person to find the correct birth certificate for as there were several candidates in that area around the right date. However, if I knew his mother's maiden name, I could ask for a certificate bearing that. The only way was to look at his siblings and see if there was a likely candidate with a less common name. He had a sister named Matilda – the only Matilda Smith born about that time in that area. The certificate was ordered and came back with the mother's maiden name of Swan. This then enabled me to find the correct birth certificate for my John Smith.

Why am I burling on about that? Well, in researching someone's family recently, I found

several trees on a well-known website with the person for whom I was looking. However, all but one of them had the parents of this person with no source documents noted – it seems that they were "name collectors" and had just copied from other published trees. The single exception was one that had found the same records that I had, which were different to the others, and had followed through with certificates. Just because a person of a certain name turns up in a particular area, that does not mean that it is the correct record. Substantiate your findings!

All being well, we will be back to a sort of "normal" before too long and able to visit Archives and Records Offices once more to find the evidence of our ancestors. Until that time, may 2021 be a successful year for your research.

# NENE VALLEY TINY FOREST TO OFFER BENEFITS FOR ENVIRONMENT

*This month, eco-minded organisations have joined forces in Peterborough to help create the region's very first 'Tiny Forest', with the aim of helping to restore biodiversity in the city and tackling climate change.*

The charity PECT, Peterborough Football and Sports Development Foundation, Peterborough City Council and The Tree Council have teamed up to plant a Tiny Forest at the Nene Valley Community Centre in Peterborough.

The team, alongside volunteers, have been planting a variety of wildflowers and 695 trees in a mixture of species to replicate the growing patterns of native woodland, but on a miniature scale. This is intended to create a fast-growing and dense forest in a tiny space, which will deliver a range of benefits for wildlife and

the environment, including increasing habitat and food sources.

The new Nene Valley Tiny Forest may be small, but it will be able to offer flood mitigation, improved air quality, a haven for numerous wildlife species and a space for people to connect with nature in an urban environment.

"Tiny Forests are still relatively uncommon in the UK, and this will be the very first created in the area," explained Councillor Alan

Dowson. "I hope that other wards in the city will follow our example, so that together we can create a network of green spaces to benefit wildlife across Peterborough and its surrounding areas."

PECT's Tony Cook said: "We are very excited to be working in partnership to plant a Tiny Forest, because we all face enormous and immediate challenges around the climate crisis that need to be tackled with innovative solutions.

"This offers a simple, collaborative and natural-inspired way to positively change the local environment. We hope local businesses and the government will hear about our environmental action and be enthused to support further Tiny Forests

across the region."

This project is also part of PECT's ambitious Forest for Peterborough project, which aims to plant over 230,000

trees in and around the city by 2030. The team would like to thank Waitrose and Nene Valley Community Centre for their support, in addition to

Viridor, Persimmon Homes, and Postcode Local Trust, a grant giving charity funded entirely by players of People's Postcode Lottery.


As Scotts marks its centenary, it is also looking to the future with continual investment helping to consolidate the next 100 years.



# Rushden fly tippers fined over £2,300

Three fly tippers have been fined £2,309 after waste that was left on the Greenway in Rushden was traced back to them.

On 26th February 2020 a large fly tip was found by a local woman strewn along the Greenway adjacent to John Clark Way.

Upon closer inspection, the woman noticed that there were names and addresses contained within the fly tip and immediately reported it to East Northamptonshire Council as there appeared to be drug related items amongst the waste. ENC Officers attended the scene where the fly tip was cleared and a large number of items of evidence were seized for further investigation.

Three suspects were identified and asked to attend an interview under caution, but none of them co-operated with the investigation and were later summoned to court. None of the three attended their court hearing and all were found guilty in their absence for littering and fined a total of £2,309.

Cllr Steven North, Leader of East

Northamptonshire Council said: "There is no excuse for fly tipping and we take any offence very seriously. Our officers work tirelessly to investigate all reports of illegally dumped waste and will take action to prosecute fly tippers.

"The Greenway is a great community asset and acts like this have a negative impact on it. In this case, we are extremely grateful that a member of the public came forward and reported it and always appreciate everyone's help in keeping the district clean and tidy.

"I would encourage anyone to come forward if they spot fly tipping but also ask that anyone looking to dispose of waste do so appropriately to avoid a fine."

Mr Grant Hinde of Rushden was fined £582, Miss Lambert was fined £876 and Mr Dion Simpson was fined £851. All three lived at the same residence.

# NEW DRAFT BUDGET HERALDS FRESH START FOR NORTH NORTHAMPTONSHIRE

*With the publication of the first ever draft revenue budget for North Northamptonshire Council, leaders of the shadow authority are emphasising that this is a fresh start for their residents.*

The total draft revenue budget for 2021/2022 is £266.2 million with the new authority providing all local government services in the north of the county including housing and economic regeneration, leisure and tourism and waste disposal and collection.

While the wider transformation programme is on target to deliver £80m savings across all eight councils in Northamptonshire, like for many councils, the Covid-19 pandemic has created pressure no one could have foreseen on finances for the coming year.

This includes higher demands on services or for help and the delay in delivering savings and the transformation of services as well as a loss of income and reduced Council Tax and Business Rates collection. While the situation is constantly changing, this has created a funding gap which currently stands at £18 million.

Measures are already being introduced to address this gap, including making sure savings that have already been planned can be delivered and also those delayed by Covid-19 can be recovered.

It is also proposed that Council Tax is increased by 4.99%, comprising 1.99% core tax and a 3%

adult social care precept, which is the maximum amount permitted.

This would contribute around £8m per annum and would represent a Band D level of Council Tax of £1,532.90 in 2021/22, or the equivalent of £29.48 per week, bringing the financial gap down to £10m.

Cllr Russell Roberts, Shadow Leader of North Northamptonshire Council, said: "This is a fresh start for North Northamptonshire Council and I'm confident that we can build on the good work that has already been started to transform services in the county.

"However, as we all know, Covid-19 has had a massive impact on everyone, not just here in the county but also worldwide, and this has had an impact on our finances at least in the short term.

"But we are working hard to address this and indeed, we are already making inroads into closing this gap.

"Local government reorganisation is absolutely right for Northamptonshire and the benefits of creating two new councils in the county is huge and will benefit everyone in the long term."

Cllr Ian Jelley, Shadow Portfolio Holder for Finances and Revenues and Benefits, said: "I would

like to acknowledge all of the hard work that has taken place to transform and develop services in the lead-up to vesting day and I'm confident that this has allowed the council to be in a strong position going forward to us becoming operational on 1st April.

"There's no doubt that Covid-19 has had a large effect on our finances but I believe that this is an obstacle that we have to overcome to take forward the good practises we now have in place, so that we can provide the very best services and support for the residents of North Northamptonshire."

The formation of the council and the reorganisation of local government in the county as a whole is expected to offer many advantages, not just for residents but in making services more efficient and cost-effective.

Sustainable, green development is at the heart of the ambition for growth in North Northamptonshire, with a desire to be an outward looking council and to take advantage

of the area's position at the centre of the country's transport network.

A growing investment in tourism, leisure and green infrastructure will be balanced with the protection and enhancement of the area's landscape and character.

The council will also assert its place within the Oxford-Cambridge Arc and link into the potential opportunities this creates.

Further integration of adult social care and health services is also key to the future of the council, with the aim of working towards a new way of delivering important services.

The draft revenue budget will be discussed at a meeting of the shadow executive meeting this month and, if approved, a consultation period will follow. For more information visit [www.northamptonshire.gov.uk](http://www.northamptonshire.gov.uk)

Following the consultation, final budget proposals will be put before the shadow executive in February.

## Latest active travel schemes announced by Northamptonshire County Council

*Footway widening in St Osyths Lane, Oundle.*

Northamptonshire County Council has announced the latest in its series of active travel schemes, following indicative funding of £351k by the Government from the Active Travel Fund.

The first block of funding is being used for temporary measures across the county to encourage people to cycle and walk, rather than use public transport.

As part of the latest developments, work has begun to widen the footways on the east side of St Osyths Lane in Oundle, from the Post Office to near the entrance to the Co-op.

Ramps will be provided to help people cross the kerbs and barriers will be installed to protect them from the moving traffic. In order to create space for the widened footway, it will be necessary to make St Osyths lane one-way in the southbound direction from Market Place to East Street.

A temporary barrier will be installed at the East Street junction to prevent northbound traffic passing that point, and northbound traffic will need to use alternative routes via either East Road or South Road and Mill Road.

The aim of the works is to help protect people who live, work and visit Oundle from the spread of Covid-19, and encourage them back to local shops and businesses in the area following the second lockdown.

The scheme will be reviewed on a regular basis to ensure its effectiveness and changes will be made if considered necessary.

Cllr Jason Smithers, County Council Cabinet Member for Highways and Place, said: "We're delighted to be able to announce the next phase of active travel schemes in the area, and we're working closely with local businesses to support their needs, while also ensuring we maximise the benefits to cyclists and pedestrians in a way that allows for Government guidelines to be met.

"We are working with Oundle Town Council to carry out these temporary works, and our priority in delivering these schemes is to support all residents in keeping everyone safe during these challenging times."

The work taking place in Oundle forms part of a number of initiatives that are taking place across Northamptonshire.

Northamptonshire County Council has launched a children's Christmas tree colouring contest in the run-up to the festive period.

Back in the summer, windows were filled with colourful rainbows to say thank you to the NHS and key workers, and the County Council hopes to see this once again – but this time with Christmas trees.

The campaign aims to bring some holiday cheer to what is going to be a slightly different festive season, and encourage children to stay indoors and get creative.

Prizes will be available from a range of local businesses, including Boost Trampoline Park, Mooch and The Little Farm Shop Company.

To enter the contest, upload a picture of your creative tree in your window to the Northamptonshire County Council Facebook, Twitter or Instagram pages using the hashtag #NorthantsTogether before Friday 18th December.

A Christmas tree template is available to download and print on the County Council website, or you can create your own. Winners will be announced the week before Christmas.

Northamptonshire County Council Assistant Director of Corporate and Community Services, Kerry Purnell, said: "Christmas this year is going to be very different for many of us, and although there is hope on the horizon, it is vital that we continue to follow the guidance in place to

keep everybody safe and move into the New Year in a more positive position.

"We hope that this contest will provide some entertainment for children while they are staying at home, and hope to see windows across the county look as colourful as they did earlier this year."

The Reverend Michelle Dalliston, Interim Vicar of Higham Ferrers and Chelveston says the new website is intended to reflect the growing number of online activities and changed circumstances brought about by the Covid-19 pandemic.

“It is important that everyone in our community and beyond is able to find information and online events quickly and easily. I am enormously grateful to the group of volunteers who have worked on this wonderful transformation.

“Since the second lockdown began our churches have seen a significant increase in the number of people listening to and sharing the online services.

“A full explanation and order of service is always available so

# COLLEGE STUDENT RECOGNISED FOR COVID-19 INSPIRED SCULPTURE

Moulton College stonemasonry student Andy Waite has had his work exhibited by Gallery DIFFERENT – a London based gallery showcasing the work of contemporary British and international artists.

Since the first lockdown, Andy has created two sculptures: a self-portrait showing the visible consequences of the pandemic and 'Isabela', a moving recognition of the loneliness Covid-19 has brought about. 'Isabela' has been exhibited at Gallery DIFFERENT and has sold to a buyer from the Worshipful Company of Masons.

Andy, who is studying Level 3 Stonemasonry at the College, said: "Adjusting to life under lockdown has been a challenge for everyone. Many of us have had to experience self-isolation during this pandemic, which has brought with it a vulnerability, anxiety, apprehension and often loneliness. I have tried to convey these emotions in my

sculpture 'Isabela', with the figure retreating into herself."

Freya Morris and Will Bowsher, studying Level 2 Stonemasonry at the College, have also been selected to have two of their works showcased at Gallery DIFFERENT. Freya's drapery relief and fish carving, and Will's anteatr and cow, are available to view as part of the gallery's online exhibition.

Emma Dexter, Stonemasonry lecturer at Moulton, added: "It's a fantastic achievement. Our students have all worked incredibly hard over the past few months to produce such outstanding work. Given that these pieces chosen for exhibition are our students' first formal stone carving submissions, I couldn't be more proud."
