## FOOD VOUCHER SCHEME FOR FEBRUARY HALF TERM

*Pupils who are eligible for Free School Meals will receive support from Northamptonshire County Council during the February Half Term.*

As stated in December, prior to the Christmas break, the council will use some of the funding it has received from the government's Covid Winter Grant Scheme to offer help.

In Northamptonshire £750,000 from the grant is being used to provide shopping vouchers for families with children who are eligible for Free School Meals with vouchers being distributed to the families by their schools.

Cllr Fiona Baker, county council cabinet member for Children, Families and Education, said: "I'm delighted that we're able to continue this support for the families and pupils who are in most need of our help.

"Many have talked about being right in the eye of the storm with regard to the Covid pandemic so it's important that we can offer this lifeline to those families and children who may be facing hardship.

"I'm very pleased that we have been allocated this money from the government as it will help make sure that we can continue to do everything we can to support people in the county through this pandemic."

The county council has been given £2,080,000 from the grant which aims to provide support for those households who are most in need with the cost of food, energy and water bills as well as other associated costs. It is primarily intended to

support families with children, with 80% of the funding earmarked for these groups.

The rest of the grant funding has been allocated to the Household Winter Support Scheme. This scheme builds on existing community resilience work to use a network of established partner organisations to distribute a one-time voucher of support to help those most in need.

Individuals will not be able to apply for a voucher directly, instead partner organisations will be able to apply for vouchers on behalf of eligible households.

The county council has also been allocated £464,280 to support the Clinically Extremely Vulnerable with



any hardship they may be facing as a result of the need to take additional precautions,

particularly during periods where the virus is more prevalent.

# WILDLIFE NEWS

It seems more than a year or so ago that we started to find new words and phrases working their way into our language, often leaving us with only a vague idea of what they meant, or whether they were important: words like 'infection', 'isolation', 'virus' or even the more familiar 'fever' and 'sanitising' taking a more sinister sound.

A new player was in our environment, with dangers we could not see, or hear, making it difficult to believe how serious this was; undetected, with no obvious death or illness in hedges or fields, it is not surprising that the more ignorant paid no attention to the much-publicised stark warnings; we have now been shown how deadly that mindlessness was.

The word 'pandemic' itself is a warning. The world has often suffered diseases heavy enough to be known as plagues, but that little extra 'pan-' tells us that there is no limit to the damage which spreads out so quickly from a single spot; remember we need a suitable defence against an enemy which came from just one small city on the other side of the world.

We always hope nature will adapt to fight the threat, as in the past, but this time it might be wishful thinking. And this has arrived when the idea of climate change is also showing how powerful environmental developments can be, though often we cannot see them; and even if we could too many of us do not consider nature's strength, from the 'invisible' right up to the massive tropical storms.

Experts in many fields used their knowledge to change our gardens and fields with new plant or animal breeds, or new treatments to improve growth, or get rid of unwanted growth. This time we lost influence over wildlife which could change our fields and meadows forever. Humans do not have a caring record over living creatures (for example, think of the rubbish in our hedges killing off other members of the living world); whatever the outcome of the current crisis we must be prepared for changes to our world. The biggest is not always the most powerful, and round here we should be looking after our valuable wildlife reserve.

# GENEALOGY JOTTINGS

You may find that, upon researching your family, they come from an area that you had never heard of. Well, you might be familiar with the large or popular towns, having been on holiday or business there. But what about the surrounding villages? I visited the town of Southwold in Suffolk on many occasions, either just as a day trip or for a holiday and felt at home in the area.

One of the places that we passed through was Theberton, where there is a rather good pub. Across the road from the pub is a house that has a couple of building ties, the initials R and B forming the ends and I always wondered whose initials they were. Some research enabled me to discover that the building had once housed Robert Bailey, a blacksmith, and his family, with the low building next to the house having been the forge. His gravestone was in the churchyard next door and reads, 'In memory of Robert Bailey, who died September 6th 1814, aged 63 years'. It was not until some while later that I discovered that Robert Bailey was in fact

my 4 x great grandfather! I have since learned a lot more about the surrounding villages.

It is always useful to have an Ordnance Survey map of the area to hand, especially if you are not familiar with that particular district. Not only that, place names can be repeated. If you suddenly find an ancestor living in Pimlico and wonder why they have moved from Potters Crouch in Hertfordshire into the depths of London, look again. The village of Pimlico is only a couple of miles from Potters Crouch.

There is plenty of access to various maps online – not just today's maps but those from previous centuries. The website <https://www.oldmapsonline.org/> is an excellent place to start and will certainly give you an insight as to how villages have grown over the years and might have become part of a sprawling metropolis today.

# PARTNERSHIP TO DELIVER TECH4KIDS ACROSS NORTHAMPTONSHIRE

Northamptonshire Community Foundation is working in partnership with Dallington based telecommunications company Guru Technology to reduce digital exclusion among children and families during lockdown through the new Tech4Kids initiative.

The Foundation is the leading grant-making charity in the county, which last year delivered over £2 million in funding to support local communities across Northamptonshire. They have pledged £20,000 to support Guru Technology in their bid to support children and families while they are trying to access online learning during lockdown.

The Foundation is working alongside Arran Kirton, Director at Guru Technology, who recently pledged £25,000 of free technology to help disadvantaged families with little or no access to laptops, iPads and the internet.

According to a report published by the Office for National Statistics in 2018, 700,000 children aged between 11 and 18 years reported

having no internet access at home from a computer or tablet, with a further 60,000 reporting they have no internet access at home at all. Digital exclusion is yet another aspect of inequality recognised on a national scale, with the current public health crisis only adding to the problem.

A Just Giving page has been set up to encourage other businesses and individuals to support the initiative to enable a bigger pot of funding to reduce digital exclusion and provide more technology to pupils in Northamptonshire.

Victoria Miles DL, CEO of Northamptonshire Community Foundation, said: "It was timely, we were discussing with our grants team the need in our communities for digital inclusion, particularly for school children and families on a low income and we were able to find some funds from the Fair Deal for Kids fund to help kick-start a campaign. I then read the story in the Chronicle and Echo about Arran's pledged support, so I got in touch to see if we could work in partnership to encourage others to give

more."

Fair Deal for Kids was originally a campaign set up by the Foundation and the Chronicle and Echo to help children in poverty. This is a way of allocating those funds to enable children to access their online learning while schools are shut for the majority of pupils.

Arran Kirton is delighted with this new partnership and added: "We started the Tech4Kids initiative first and foremost because our business deals in telephony and communications and clearly that is what's lacking in the UK right now. With 12-14% of children unable to home school because of a tech issue, it was our duty to step forwards and try and create awareness and donations to help as many families and businesses as possible operate and collaborate during these challenging times.

"As a company, we pride ourselves on being different in the market and we hope that the start of Tech4Kids is the embodiment of our companies' dreams and ambitions to change people's lives."



Last year, Northamptonshire Community Foundation made a commitment to adopt the United Nations Sustainable Development Goals (UN SDGs) into its charitable activity. The Tech4Kids initiative

demonstrates this commitment, aligning with their work towards eliminating poverty and supporting quality education across Northamptonshire (UN SDG 1 and 4 respectively).

# TAKE PART: UCL RESEARCH ON VIDEO CALLS

*During the COVID-19 pandemic, there has been a huge increase in the use of video calls as a way to stay connected with others and improve wellbeing. Staying connected is especially important for people aged 70 and above who have been advised to self-isolate for long periods of time.*

However, there may be barriers to video call use, including difficulties with hearing. We are interested in finding out how and to what extent older people with hearing loss have been using video calls, focusing on ease or difficulty of use and any effects on feelings of loneliness and isolation.

## Take part in our survey

We've launched a survey to find out about these things and we'd love you to take part, whether you use video calls frequently or hardly at all and whether you love them or loathe them (or something in between). You can complete the survey online or, if you prefer, fill in a paper copy. It should take roughly half an hour. We will also conduct a smaller number of in-depth interviews to find out more detail about people's experiences; you can volunteer for an interview via the

survey.

This project is a collaboration between four different UCL departments: the Ear Institute, Centre for Behaviour Change, Division of Psychiatry and Institute of Health Informatics. We will use the results of our investigations to write recommendations about making video conferencing more accessible to older people with hearing loss. We believe that the information we gather will be valuable in helping older people with hearing loss cope with further periods of isolation, either due to



the pandemic or other life events.

## Your Health – Shoulder pain

With a number of our team having had specialist training in shoulder treatments we've been interested to see how many people have had shoulder pain since this time last year.

Our suspicion is that doing unsupervised exercises at home, lots of video calls with family and working on laptops while sitting on the sofa are all contributing to these shoulder problems.

So what can you do about the pain?

Here are a few shoulder tips from our osteopaths, sports therapists and chartered physiotherapist:

1. If you get night pain, try lying on your side with your arm resting on a pillow.
  2. Start to build up the strength of your shoulder muscles, but do this slowly and carefully. Don't start doing press-ups straight away!
  3. Keep moving. Unless you've got a severe injury you're better off keeping a bit of movement in the area. Using a sling or support doesn't normally help.
  4. If you feel you need to use a sling or support you MUST get the shoulder investigated. The longer you leave it the longer it could take to heal.
  5. Remember that putting the washing up away, hanging laundry and moving things on shelves can all be used as rehab. 30 years ago we'd have got you to rearrange your vinyl as a form of rehab, but the modern equivalent of asking Siri or Alexa to 'shuffle my music' is not quite as effective.
  6. If the injury isn't severe, you might find that kinesio tape or pain relieving gels work well, or an ice pack.
  7. If any of the above aggravate the pain, get it looked at by a GP or specialist this week. Oh, and watch out for lifting or moving heavy items as you don't want to cause a flare up in that shoulder, which means... no lawnmowing for a few weeks!
- Have a gentle, pain-free week.

## BUS LANE ENFORCEMENT TO IMPROVE JOURNEY TIMES

**Northamptonshire County Council will crack down on vehicles illegally using bus lanes – improving journey times for bus users.**

The authority will use number-plate recognition cameras to discourage illicit use of the lanes, with fines being issued to offenders. Enforcement starts on Monday 1st February but during January, warning notices will be issued to those who flout the rules to act as a warning.

Freeing up the bus lanes makes bus journey times more reliable and therefore a more attractive mode of transport. It also encourages people to make cycle journeys along the routes with the lanes being relatively safe with lighter traffic.

The measures will be introduced at three sites in Northamptonshire:

- Drapery, Northampton town

centre

- Weedon Road/St James' Road, Northampton
- The bus gate linking Church Street to Cambridge Street in Wellingborough town centre

The need for such measures has already been scoped-out, with three trial sites in the county having had cameras installed to check the level of contraventions:

- Bus gate, Wellingborough town centre – 11,110 over 18 days
- Weedon Road, Northampton – 723 over 16 days
- Drapery, Northampton – 2,987 over 7 days

Cllr Jason Smithers, county council cabinet member for Transport, Highways and Environment, said: "Part of the solution to reducing congestion and pollution is to encourage people to use more sustainable

forms of transport.

"A real challenge to promoting bus travel is guaranteeing reliable journey times. I believe this plan will make significant improvements in making bus travel an attractive option for commuters.

"I also think it will encourage cycling as the bus lanes, if free of cars, are fairly traffic light and better for those who choose pedal power.

"Obviously at the moment with the Covid-19 pandemic people should only be making essential journeys but this infrastructure will continue to be in place once restrictions are lifted."

The bus lane enforcement scheme has been in development for more than a year and is an extension of the existing parking enforcement controls.

## Anglian Water unlocks second half of £1million funding pot to help communities

**Hundreds of local causes continue to benefit from Anglian Water's community funding.**

Almost a year ago, Anglian Water launched plans to establish a new £1 million community support fund to provide a cash boost for local communities to meet emerging needs arising from the pandemic.

Last year, half of the company's Positive Difference Fund (PDF) was made available to help front-line organisations in the immediate response to the pandemic. The water company has recently announced the remaining funds are to be made available to help communities meet emerging needs and adapt following almost a year of Covid impact.

Anglian will continue working with 15 Community Foundations in the East of England and Hartlepool to allocate the Fund. The money will help local charitable organisations deal with issues in the community as a result of the continuing threat of coronavirus.

Organisations like food banks, outreach programmes and those helping the most vulnerable can ask for continuing support from the Positive Difference Fund via the Community Foundations to help those experiencing financial hardship, potential for hunger, lack of shelter, access to education, further exacerbation of health issues, loneliness and isolation.

Last summer, the first £500,000 distributed from the fund helped over 88,000 people via 124 community organisations.

The second phase will help to meet emerging needs resulting from the ongoing pandemic and help groups and communities to adapt and rebuild. Full details and eligibility criteria can be found on the Community Foundations website.

Peter Simpson, Anglian Water's Chief Executive, said: "No one would have believed a year ago, what a different world we'd be living in by 2021.

All our lives have been affected by the pandemic in some way.

"As one of the biggest businesses in the East of England, we made a commitment to continue offering support to our local communities as their needs change. We sincerely hope this second tranche of funding will help continue some of the incredible work that's already been started and support recovery in the longer term.

"I'm proud that we've been able to make even a small difference to so many people already. But our work is not done. Alongside the Positive Difference Fund, we'll keep working to support our customers in the best way we know how – by keeping taps running and toilets flushing, because access to water for health and hygiene has never been more important."



# FOUR TIPS FOR KEEPING YOUR CAR IN PEAK CONDITION DURING LOCKDOWN

*With the UK back to the instruction of 'essential trips only', cars across the country are gathering dust on driveways and in garages.*

To make sure your car is in working condition when the time comes for you to get back on the road, a Lincoln car retailer is offering some easy tips for local residents.

Andy McInnes, Business Manager at Stoneacre Lincoln, on Lincoln Fields, said: "Like everyone else,

we're really looking forward to getting back on the roads, going on holiday and visiting friends and family across the country when we can. However, after months of being largely stationary, your car might not be in peak condition to set off on a long journey straight away.

"There are a number of quick and easy steps you can take at home to ensure your car isn't deteriorating due to a lack of use."

Here are Andy's top tips:

## 1 Battery basics

A good baseline for battery usage is to run your car's engine for five minutes every three or four days when your car isn't being used. This helps ensure the battery stays charged. The battery would usually recharge as you drive the car, so when the car is not in use, the battery is more likely to go flat without you noticing.

## 2 Perfect placement

Storing your car on the side of the road for weeks on end isn't ideal for keeping it in perfect condition because it'll be exposed to direct sunlight, rain and dust. It's a good idea to try to park your car somewhere sheltered

such as a garage. However, if this isn't possible, it might be a good idea to invest in a car cover to help protect your car from the elements. This will also mean you avoid being met with frost-covered windows when you're on your way to the shop!

## 3 Idle time

It is actually a myth that you need to leave your car's engine on for a few minutes before you set off to 'warm it up'. This, in fact, wastes fuel unnecessarily and is harmful to the environment – all that is required is 30 seconds to circulate the engine's oil, then you're good to go. The best way to bring your engine up to operating temperature is to drive the car gently at first.

## 4 Correct pressure

A car's tyres naturally lose pressure over time, and it's all too easy to miss this when your car is parked up for weeks on end. On average, tyres lose about one to two PSI



of pressure per month, so be sure to check them before you drive your car again, even if it's just a short journey. Use a tyre pressure gauge to check your tyres are correctly inflated (you'll find the recommended pressure in your car's handbook, on the car's bodywork you see when you open the driver's door, or on the inside of the fuel filler cap). If the pressures are even slightly lower than recommended, using a foot pump or visiting a local petrol station to fill them up will set them right.

items they no longer need.

Collections will be arranged for a convenient time, and will be contactless; where possible equipment can be picked up from outside the home to help ensure everyone stays safe.

Alternatively people can deliver to the following Covid-safe collection points:

- 1 Church of Jesus Christ of Latter Day Saints, 137 Harlestone Road, Northampton NN5 6AA. Tuesdays 3pm-7pm, Thursdays 9am-12noon.
- 2 Millbrook Healthcare Depot, 9A North Portway Close, Round Spinney Industrial Estate, Northampton NN3 8RQ. Mondays to Fridays 9am-5pm.

Collected equipment will be fully tested, refurbished and thoroughly cleaned before being reused.

Northamptonshire County Council cabinet member for adult social care, Councillor Ian Morris said: "Coronavirus has caused a significant increase in the need for vital community equipment, so if anyone has these items that they no longer require please can they make arrangements to return them as soon as possible.

"We would ask everyone to also please share this message with your contacts and communities and help us spread the word that this equipment is urgently needed."

The Integrated Community Equipment Service is jointly funded by Northamptonshire County Council and NHS Northamptonshire CCG, and is provided on their behalf by Millbrook Healthcare.

# TENFOLD INCREASE IN GIGABIT BROADBAND COVERAGE

*With more people than ever working from home and increased home-schooling in response to the latest national lockdown, access to fast and reliable broadband is more crucial than ever.*

**Government targets are increasingly focusing on gigabit capable broadband – networks able to support speeds of a gigabit per second (Gbps) – as the new benchmark.**

Due to efforts through the Superfast Northamptonshire initiative and commercial telecoms investment, access to this new benchmark has increased tenfold in the last five years in Northamptonshire. This is according to [www.thinkbroadband.com](http://www.thinkbroadband.com) (the UK's largest independent broadband news and information site).

In January 2016, gigabit broadband was only available to 1.7% of premises in the county compared to 17.42% reported in January 2021. The Northamptonshire figures are even more impressive as they reflect full fibre network coverage. This means that it is future-proofed for speeds in excess of one Gbps, which is especially important as demand increases.

The Government's previous benchmark has been superfast broadband coverage. This means access line speeds above 30 megabits per second (Mbps). Coverage of superfast broadband has also increased (by almost 9%) in the same period, and now stands at 98.5%. Efforts are also continuing to address those areas with slower speeds.

The focus of the superfast Northamptonshire initiative is now to work with telecoms providers to encourage and support further investment to extend faster and reliable broadband in Northamptonshire.

Contracts with Gigaclear Networks will see around 7,000 premises connected by full fibre with the support of public investment by the end of next year, and together with their current commercial investment should see over 30,000 rural properties benefit overall.

Recent announcements by

Openreach on its 'Fibre First' programme have boosted plans for gigabit coverage in Daventry, Towcester, Rushden and the south of Northampton exchange areas.

With CityFibre rapidly expanding their footprint in Northampton, and OFNL covering parts of Corby, along with the forthcoming VirginMedia network upgrade to DOCSIS 3.1, the overall picture is looking very positive.

It also means that Northamptonshire is on track to meet its local targets which are for 40% of premises to be served by full fibre networks by the end of 2023, and 75% coverage of gigabit capable networks, by the same date. These are both challenging targets and complement the Government's current ambition to see 85% gigabit coverage nationally by 2025.

In support of its 85% national coverage target, the Government has announced

a new national gigabit programme. This will focus on the estimated final 20% of premises nationally which are unlikely to benefit from commercial investment in gigabit broadband.

Through the superfast Northamptonshire initiative, the County Council is working with Building Digital UK (BDUK) – the government

team leading on all things broadband – to ensure this further investment benefits Northamptonshire, and is targeted where commercial plans are unlikely to come forward.

Jason Smithers, cabinet member for Highways and Place for Northamptonshire County Council said: "Whilst government led and funded,

it is vital that local bodies and initiatives, such as Superfast Northamptonshire, have an important role to play in the new programme because of their local knowledge, existing relationships with key stakeholders, role as highway authority and experience of problem solving.

"This is a message that we will be playing back to Government through BDUK, and we expect the first procurements to come forward later this year."

## Countdown to the new North Northamptonshire Council

**There are just three months to go before the creation of the new North Northamptonshire Council, with vesting day on 1st April 2021.**

The new authority will take over responsibility for the services currently delivered by the Borough Council of Wellingborough, Corby Borough Council, East Northamptonshire Council, Kettering Borough Council and many of the services provided by Northamptonshire County Council.

Local authorities in the area are working closely to ensure

a smooth transition to the new North Northamptonshire Council.

The focus for day one will be to provide continuity and efficient delivery in the services to residents and businesses. A programme of continuous service improvement will remain in place and will remain a priority moving forwards.

Cllr Russell Roberts, Leader of North Northamptonshire Shadow Authority, said: "Clearly we are all living in very challenging times. The continuity of public services has never been so important. Providing vital services to our local residents will remain our

number one priority.

"We do have a real opportunity to do things in a way that makes an even bigger difference in the future and we are committed to further improving public services in the area.

"The pandemic continues to see public services at full stretch, but this does not dent our ambitions for this fresh chapter of local government."

A coordinated public information campaign will soon be launched that will help ensure that local residents and businesses are fully aware of what is happening and when.

## RECIPE: PERFECT PASTA



**> PENNE RIGATE WITH TOMATO, BASIL, AUBERGINE AND GARLIC**  
**Prep time: 10 minutes**  
**Cooking time: 20 minutes**  
**Skill: Casual**

**Ingredients for 4 people:**

- 350g Barilla® Penne Rigate

**Cooking time: 15 minutes**  
**Skill: Casual**

### Ingredients for 2 people:

- 160g Barilla® Fusilli

Francis Pryor has lived in, excavated, farmed, walked – and loved – the Fen Country for more than 40 years: its levels and drains, its soaring churches, its magnificent medieval buildings. The Fens is a personal story of the author's discovery, as both an archaeologist and farmer, of this distinctive, complex, enduring, man-made and little understood landscape.

In The Fens, Francis counterpoints the history of the Fen landscape and its transformation – the great drainage projects that created the Old and New Bedford Rivers, the Ouse Washes and Bedford Levels, the rise of prosperous towns and cities, such as King's Lynn, Cambridge, Wisbech, Boston and Spalding – with the story of his own discovery of it as an archaeologist.

As well as exploring the history of this rich landscape, Francis looks to the future of the Fens. Combining beautiful prose with nature writing, history and memoir, he investigates how rising seas might affect this flat expanse, whose land often falls below sea-level.

Francis Pryor is one of Britain's most distinguished living archaeologists, and the excavator of Flag Fen. He was awarded an MBE 'for services to tourism' in 1999. Fengate was published in four volumes in the 1970s and '80s and major English Heritage monographs on Maxey, Etton and Flag Fen appeared in 1986, 1998 and 2001. His popular account of this remarkable site, Flag Fen: life and death of a prehistoric landscape, was revised for a second edition in 2005.

He was President of the Council for British Archaeology from 1998-2005 and has written and presented series for Channel 4 on Britain BC, Britain AD and The Real Dad's Army, a review of archaeological remains surviving from 1940 and has regularly appeared on Channel 4's Time Team. He is a keen farmer, and lives on a smallholding in the Fenland with his wife.




