Cllr Jason Smithers, Leader of the council, said: "I'm delighted that we're able to continue this support for the families and pupils who are in most need of our help.

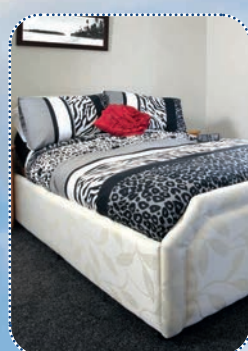
"I'm very pleased that we have been allocated this

WILDLIFE NEWS

All over the world weather reports (not just forecasts) are of increasing violence with tragic stories of thousands of lives being lost with the power of wind, sun and perhaps most marked this year, rain increasing the damage every day.

It does not always reach media deadlines, or stay there for more than a day, but damage to both natural and artificial environments continues, with severe effects emphasising that in battles against nature we humans are usually at a disadvantage. We are slowly realising that something needs to be done – and quickly – as the media generally make us more familiar with phrases like “global warming”, and more broadly “climate change”.

For this danger concerns everybody, not just animals and plants. Plants die out as natural crops fail, with animals then finding that they run out of food, and the cycle carries on. Much of our region has coped with the difficulties, partly because ‘our’ river, the Nene, is quite wide, and excess water in streams and smaller rivers, like the Ise, finds ways to escape; but changes in roads and houses often

mean that the usual channels are blocked, and water levels rise higher and more quickly than planning authorities had expected – which clearly leads to flood damage.

We hear when people and property are tragically involved, and it is easy to forget the natural species of our countryside – plants and animals we have taken for granted because their lifestyles have been formed in the places where they live.

We know that plants need water to live, so we water our gardens and the ‘locals’ continue their normal lives, but “too much of a good thing” and plants can literally drown. Animals, of course, can move, but water surges can still drown.

Farmers have problems, especially in timing; varieties may need different weather patterns. When they get it wrong they can lose some, or even all of their crop (and annual income).

If we do not do something about our changing climate we could be equally in danger – even if it takes longer.

GENEALOGY JOTTINGS

Of everyone who reads the Nene Valley News, I bet that I am not the only one to have convict ancestors! Apart from the odd criminal in Britain, I also lay claim to a couple who ended up in Australia – one for stealing stockings from the Vicar of Shudy Camps in Cambridgeshire and another for robbing his uncle in Tenterden, Kent. When you consider that these transportations had originally been death sentences, it certainly makes you wonder about whether punishments fit the crimes back then!

A really great website that was brought to my attention a couple of weeks ago is that of Claim a Convict at <http://www.hawkesbury.net.au/claimaconvict/>. By searching for the name of your convict ancestor, or the ship on which they sailed, you can learn what information may have been discovered about them – plus be able to contact other people who have an interest in that person. One of mine had a contact but the other convict was not listed. I was able to add the information

that I had discovered about him, hopefully to help others who may be researching him.

I do like criminal ancestors as you can discover so much more about the person. I was following an ancestral line for someone a couple of years ago and found that they also had a criminal in their family’s history. The person started out just with dates of birth, baptism, marriage, death and burial – all very factual, but the criminal records provided so much more. At the age of 38, they were 5’11” tall, had black hair and blue eyes. Their complexion was recorded as being “sallow” and they weighed 9 and a half stone. The records of ten years later – yes they were still committing crimes! – state that the black hair was turning grey, they had lost their teeth and their weight was a stone lighter. These descriptions certainly paint a picture rather than just being a name on a page!

CORBY WELLNESS HUB TACKLES DOMESTIC ABUSE

North Northants Council’s Safer Corby Team are working with the Urgent Care Centre Wellness Hub Team to raise awareness around domestic abuse.

Throughout the remainder of August, an information display will be viewable to the public at the Urgent Care Centre on Cottingham Road, Corby. This is following statistics released by UK domestic abuse charity, Women’s Aid, which sadly showed an increase in domestic abuse through the Covid-19 pandemic.

The Office for National Statistics figures show every year that one in three victims of domestic abuse are male equating to 757,000 men (1.561m women). One in 6-7 men and 1 in 4 women will be a victim of domestic abuse in their lifetime. According to the charity Mankind Initiative, 11% of male victims have considered taking their life due to partner abuse. The charity has seen an

increase in calls regarding suicide over the pandemic period.

As well as the informative display, health professionals such as nurses and GPs will be handing out an information flyer to each patient, providing advice on where to go if either they, or someone they know, has been affected by domestic abuse. The flyer contains guidance both for survivors and perpetrators.

Eleanor Finnerty, Patient Advisor from the Wellness Hub said: ‘The Wellness Hub at Corby Urgent Care Centre has been supporting members of our Corby community with their wellbeing needs for nearly 18 months now, and we have learnt that it is a vital part of people’s wellbeing to feel safe within their homes and local area. We are excited to be involved with Safer Corby to aid in the promotion of local support services and to work with them in raising awareness of important issues.’

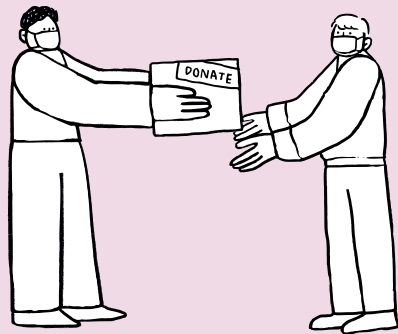

Foundation awards £371,000 to help local community projects



Since April, Northamptonshire Community Foundation has awarded £371,367.85 in grant awards on behalf of its donors to groups, charities and community projects across the county.

This follows up its distribution of £2.5 million across Northamptonshire during 2020 where it awarded emergency funds to support vulnerable local residents during the Covid-19 public health crisis.

Recently funded projects include an array of activities and services to help support the pandemic recovery and local residents' wellbeing including Broughton Playing Fields and Village Hall to put on a village show and fun day, Spring Boroughs Voice putting on a day of festival activities for local residents, Rushton Pocket Park to make improvements for the enjoyment and wellbeing of residents and the Outside In Theatre to create new arts

experiences for older people and their carers.

The Foundation is the leading, independent grant-making charity in the county, working with a network of fund holders and donors to ensure projects make a sustainable impact on local need.

This year has seen the launch of several new funds on behalf of national and local donors and partners including the Family Food Aid Fund helping families experiencing financial hardship and the MBS #ClubsInCrisis supporting sustainable sports activity for young people.

Following on from a series of community conversations it has also launched The Constance Travis Endowment Fund – the Global Goals

Fund which aims to fund a broad range of projects.

Northamptonshire Community Foundation has adopted the United Nations Sustainable Development Goals (UN SDGs) into its charitable activity. The organisation wants to help promote the global goals locally to show how local action contributes to global good.

The UN SDGs are 17 goals set to help improve quality of life and wellbeing for all by 2030 and include tackling poverty, hunger, access to quality education and health and wellbeing.

Rachel McGrath, Deputy CEO at Northamptonshire Community Foundation, said: "We have hit the ground running to ensure funds are available

to local community groups and charities as we continue to recover from the impact of the pandemic. We are committed to being a fair and flexible place-based funder and have a number of rolling programmes so that local organisations can apply at any time.

Your Health – Where's your hand?

Sit up! No really, sit up. Now put your arms out in front of you (if you can't do this because of shoulder pain call us!). Now close your eyes and lift one arm up high and drop the other low. Hold them there for 10 seconds. Now put your arms in front of you again and try to make them level with each other. Open your eyes. Your arms aren't level, are they?

Even when you're not injured your brain can play tricks with you. And when you're injured, or recovering from an injury, your brain can play even more tricks on you.

Many years ago, when I was in hospital with a very badly broken leg I was convinced that my leg was bent at the knee when I was lying down, but when I opened my eyes it was always



straight. Of course, I didn't mention this to the nurses, but sometime later I read that psychiatrist Oliver Sacks (who wrote Awakenings, the book and movie) had a very similar experience.

So if you're recovering from surgery or an injury make sure you are doing things that help your brain. This is the

reason rehab therapists use wobble boards and wobble cushions with patients and the reason you might be given exercises that seem a bit easy or pointless!

Warning - you do need to be suspicious if your therapists suggests you mow their lawn as part of your rehab!

"Underpinning all of this is how we do this in an environmentally sustainable way so that we can preserve the unique character of North Northants and maximise the benefits for residents and businesses."

MOULTON COLLEGE ALUMNUS SHOWS GARDEN DESIGN FLAIR

James Smith, Horticulture alumnus from Moulton College was invited to showcase his garden design 'It's okay not to be okay' at the recent RHS Flower Show Tatton Park. Alex Pettitt, Managing Director at Topoforma Landscape, the company in charge of building James's design, also studied at the College.

Alex Pettitt, Managing Director at Topoforma Landscape said: "James is our Consultant Landscape Designer, and it was great fun working with him to fulfil his vision for this design.

"The focus of his work to highlight the benefits of nature and mental health, and initiate healthy conversations around the topic couldn't have come at a better time. Myself and James both studied Horticulture at Moulton College and without doubt, the teaching and facilities at the College have helped us get to where we are today."
